- The Natural Resource Policy committee has met and reorganized. They have an ambitious agenda put together. They are to meet again on May 26th.
- The proposed MOU with Purdue was presented for approval. **Moved by** Josh Bishop to approve said MOU, seconded, **Passed**. (Ray Chattin abstained due to his position on the SSCB)
- It was moved by Jeff Meinders to accept the IASWCD Travel Policy as presented, seconded, Passed.
- A legislative update was given. District visits have gone well. Tom attended the February 13th

Senate hearing on Senate Bill #420 and reported on that.

- A task force to review the current bylaws and personnel policies was formed. Jeff Meinders and Roger Wenning are to join Ray Chattin for that review.
- It was moved by Marc Roberts to appoint Steve Gauck as the North Southeast Assistant Region Director, seconded, Passed
