Welcome to the Second Session of the 121th Indiana General Assembly

Governor Holcomb's "State of the State" address on Tuesday evening and Chief Justice Rush's "State of the Judiciary" on Wednesday highlighted a busy second week of the 2020 "short" session of the Indiana General Assembly Biennium Session. Committee hearings are at a very fast pace. Final bill lists were handed down and please note that several bills have been added to our tracker list this week.

Committee hearing deadlines are approaching and you can find links below to follow schedules.

2020 Session Deadlines

- 1/28 last day for first Committee Hearings
- 2/3 last day for 3rd readings of House Bills
- 2/4 last day for 3rd readings of Senate Bills
- 3/3 last day for 3rd readings of House Bills in Senate
- 3/3 last day for 3rd readings of Senate Bills in House
- 3/14 last day for adjournment of both houses
